### Exchange Income Corporation Announces February 2014 Dividend

**WINNIPEG, Manitoba – February 18, 2014** – Exchange Income Corporation (TSX: EIF) (the “Corporation”), announced today that the Directors of the Corporation have declared eligible dividends totaling \$0.14 per share for the month ended February 28, 2014, payable March 14, 2014 to shareholders of record at the close of business on February 28, 2014.

Eligible shareholders have the opportunity to reinvest their dividends in accordance with the Corporation’s dividend reinvestment and cash purchase plan. The dividend is designated as an “eligible” dividend under the Income Tax Act (Canada) and any corresponding provincial legislation. Under this legislation, individuals resident in Canada may be entitled to enhanced dividend tax credits which reduce income tax otherwise payable.

The Corporation is currently operating in two niche business segments: aviation and specialty manufacturing. The aviation segment consists of the operations by Perimeter Aviation, Keewatin Air, Calm Air International, Bearskin Lake Air Service, Custom Helicopters and Regional One, and the specialty manufacturing segment consists of the operations by Jasper Tank, Overlanders Manufacturing, Water Blast Manufacturing, Stainless Fabrication and WesTower Communications.
